No Sunday burning notice in Community Spirit after reported that Sunday burning was happening.

FESA has taken Bandalup LD

Emergency Services Survey completed – no results as yet.

CO2 review conducted.

Various fire mitigations attended – local, state and district.

Protective burning – wind driven buffer programme is way behind due to lack of finances.

People are using permit system with 40 issued since 14/4.

Pleased to see more firebreaks in Hopetoun subdivisions.

Fire trucks are receiving annual service.

Radio checks is being organised prior to new season.

Munglinup have new truck and a training was held

I have concern that the newly introduces charges for rubbish taken to the Ravensthorpe and Hopetoun tip is going to encourage more rubbish in the bush and more burning conducted at home. A better idea may be to give people \$5 when they take it to the tip.

Thanks to my fellow FCOs, Chief Executive Officer, CESM and FESA and DEC staff for their support in this period.

I am concerned about the huge build-up of fuels in our surrounding bushland so please be vigilant, we are due for a couple of big ones again soon.
