Summary:

A series of tenders have been called for packages of works for the repairs of shire roads as a result of the February 2017 flood event. The event has been declared a natural disaster and that has triggered funding – WANDRRA AGRN 743 is the allocated reference number.

The submissions to the initial tenders have been assessed by Council's consultants, OPUS, against the criteria outlined in the tender documents and a report prepared.

The report is now submitted to Council for consideration and adoption of the recommendations.

Background:

The flood event of February 2017 severely impacted some 90 local governments including the Shire of Ravensthorpe. The event was declared a natural disaster and this has triggered disaster relief funding under WANDRRA.

Once the event was declared a disaster a process of assessing and recording each area of damage was required with a cost estimate for repairs prepared. All this documentation is then presented to Main Roads WA for their assessment and subsequent approval.

Comment:

It is only after the approvals are received that the process of carrying out repairs can be initiated. Working with our consultants, Main Roads WA and Office of Emergency Management a series of works packages across areas of the shire have been developed and tenders called for the first 6 works packages – it is estimated there will be in the order of 30 works packages that will require tenders to be called – tenders are required for works packages that are over \$150,000 in value.

The report from OPUS attached to this item outlines the tenders received and the assessment against the established criteria. A map is included that identifies the area/roads that are included in each package.
