# Executive Summary

It was identified in the Shires 2010 – 2015 Strategic Plan and the 2007 – 2010 Community Safety Plan to develop a Youth Strategy that focuses on delivering more activities for young people. It is expected that more families will be moving to both Ravensthorpe and Hopetoun to work in the mining industry and as such there will be an increase in young people. Although current crime statistics show that crime rates are low the rise in population may see an increase in anti social behaviour if young people are unable to participate in fun, safe and constructive activities.

In order to determine the kind of facilities and activities young people would like in Ravensthorpe, a series of focus groups took place involving 66 students from Ravensthorpe District High School (RDHS) and Hopetoun Primary School (HPS). The broader community were also invited to attend one of two consultations in Ravensthorpe and Hopetoun. Due to the poor attendance at the consultations a survey was developed to capture the thoughts and comments of the wider community.

A popular assertion is that there are currently very few activities for young people apart from structured recreation, such as team sports. In Ravensthorpe, there is very little infrastructure or activities for young people. Access to existing facilities such as the public swimming pool is also limited as children need to be accompanied by an adult. Hopetoun has a skate park however it is considered to be too small and unsafe.

Access to transport was identified as a major issue for young people. One of the major challenges is that young people live out of town on the family farm and are unable to make their own way into town. Young people are also unable to travel between Ravensthorpe and Hopetoun without relying on parents.

Participants identified a need for a dedicated place for young people to meet. The most popular suggestions included skate parks and a youth centres in both Ravensthorpe and Hopetoun. Young people also wanted to see more water activities.

This Youth Activity Plan lists a number of recommendations to help address the challenges and barriers identified by young people. These recommendations focus on improving and building new infrastructure, providing a range of activities so young people have a choice, improving access to transport, ensuring young people have a voice in the community, establishing partnerships at a local level and ensuring there are adequate resources to deliver the plan.



# Introduction

Prior community consultation within the Shire of Ravensthorpe has highlighted the need for youth facilities and activities for young people within the Shire. This Youth Activity Plan has been developed to identify the gaps in infrastructure and activities particularly for young people aged between twelve and eighteen. In order to determine the kind of facilities and activities young people would like in Ravensthorpe, a series of focus groups took place involving 66 students from Ravensthorpe District High School (RDHS) and Hopetoun Primary School (HPS).

The research shows that there is a need for more outdoor spaces and indoor facilities that are easily accessible and support affordable unstructured activities for young people in Ravensthorpe and Hopetoun. The major barriers to participation in both structured and unstructured activities are the limited options on offer and difficulty accessing existing activities. Strategically located outdoor and indoor spaces will help to address these constraints.

A number of recommendations have been formulated based on the feedback from the young people and the community. These recommendations address the barriers and gaps identified and include a range of appealing, safe and affordable facilities and activities, improving transport and access between Ravensthorpe and Hopetoun, building partnerships within the community, ensuring there are adequate staff resources and ensuring that young people have a voice in the community.

It is important for young people to be involved in the design of the 'unique places' as the places are likely to be more appealing and therefore utilised and respected if young people are involved. This includes young people who may be inclined to vandalise an area. The success of this plan relies on the ongoing consultation of young people. All projects that result from recommendations in this report need to involve young people throughout the planning process.

# Background

The Shire of Ravensthorpe has two main towns; Ravensthorpe and Hopetoun, with three surrounding settlements of Fitzgerald, Jerdacuttup and Munglinup. The 2006 Australian Bureau of Statistics Census data shows that the Shire of Ravensthorpe had a population of 1,972. Since then the Shire has seen large variations within the population due to the volatile mining industry in particular the Ravensthorpe Nickel Project (RNP).

The BHP Billiton RNP was officially opened in May 2008. In order to predict the level of demand on the Shire, the Shire of Ravensthorpe contracted LAND inSights in collaboration with Data Analysis Australia in 2007 to provide a population forecast to be used in the Local Planning Strategy.



The Local Planning Strategy Review 2007 – Population Projections report used information based on the intended number and timing of BHP employees and associated people, such as their families and also additional people due to the multiplier. The population forecast can be seen in table one, this shows the medium scenario. The medium scenario is a population projection that is appropriate for most planning projects. Tables two and three show the projected population pyramids that are broken breakdown by age and gender.

### Medium Scenario Population Pyramid 2016

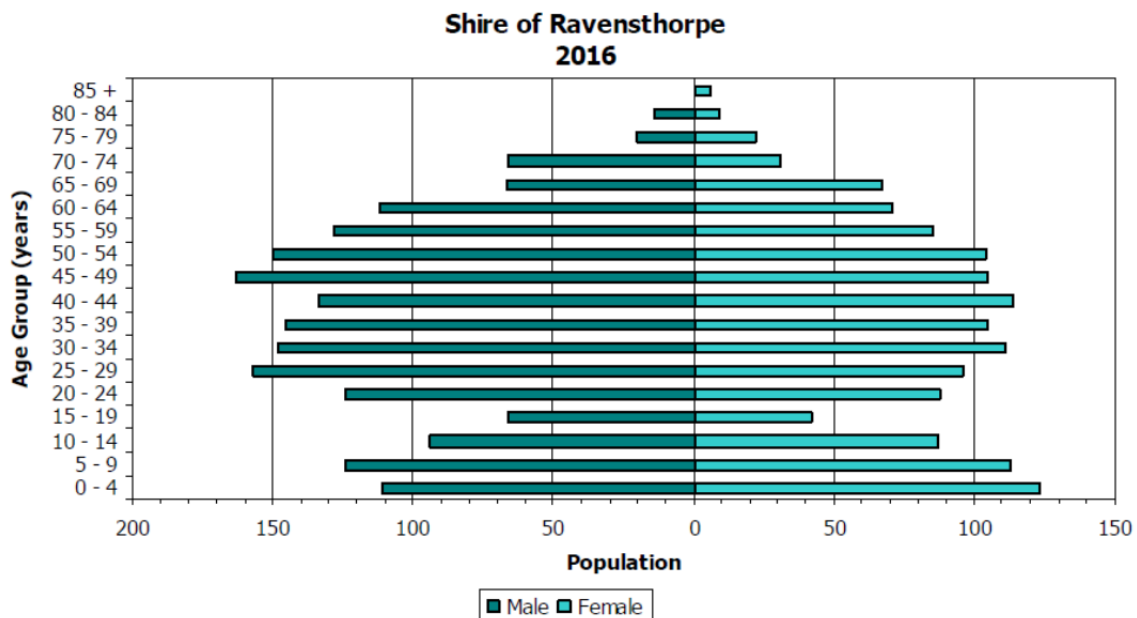

## Medium Scenario Population Pyramid 2021

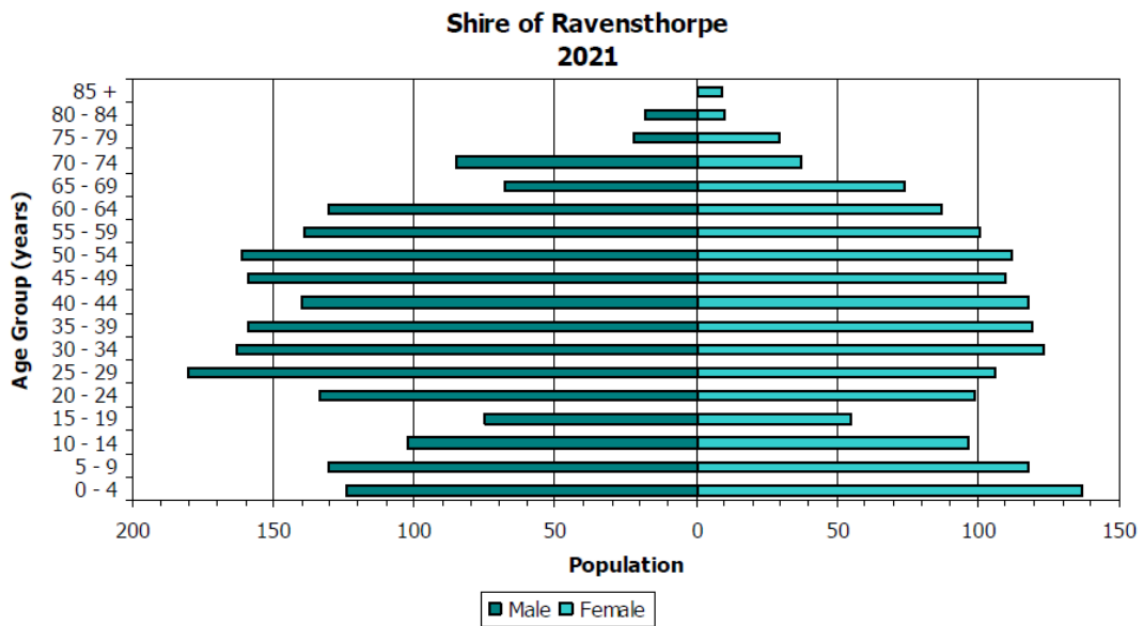

BHP ceased operation in January 2009 which led to a significant decline in population and meant the previous population projections provided in the 2007 report needed revision. In October 2009 the Ravensthorpe Shire Population Projections report was released. This report provided four population scenarios, scenarios two and three as shown in tables four and five were the medium population projection and are considered to be appropriate for most planning objectives.

In the Ravensthorpe Shire Population Projections report, Data Analysis Australia recommended revising the population projections for the Shire of Ravensthorpe should there be any developments in the Shire with regards to employment prospects. In early 2010 First Quantum began operations on the RNP. Whilst it is difficult to determine the impact First Quantum will have on population numbers it is recognised that numbers will be higher than that forecasted in the latest Populations Projections report, although numbers may not rise to the level predicted in the Local Planning Strategy Review 2007 – Population Projections report. With more families moving to the area to work on the RNP, Hopetoun and Ravensthorpe will see an increase of young people and it is important to provide facilities and services that will cater to their needs.

The Shire of Ravensthorpe's 2011 Service Delivery Questionnaire highlighted the need for youth facilities and activities for young people within the Shire. 41% of respondents stated that the level of services and facilities provided for youth/teenagers is below average. It has been identified in the Shires 2010 – 2015 Strategic Plan and the 2007 – 2010 Community Safety Plan to develop a Youth Strategy that focuses on delivering more activities for young people.

The Shire of Ravensthorpe Community Safety Plan 2007 – 2010 highlights that crime rates experienced in Ravensthorpe between 1996 and 2004 were well below those in the region and the state for most years in the series for all offence categories, except drug offences. Western Australian Police Statistics show that crime rates in Ravensthorpe and Hopetoun is still low from July 2009 to December 2010 (please see appendix two). Whilst recognising that crime rates are low the report states that the majority of those who were consulted appreciated that early intervention with children and youth in providing them with constructive activities will significantly contribute to deterring them from crime later in their childhood and teenage years.

The Shire Community Safety Plan 2007-2010 recommends that:

- Youth services and activities are required in both Hopetoun and Ravensthorpe.



- Hopetoun and Ravensthorpe Progress Associations, Primary and Secondary Schools and the Shire of Ravensthorpe should be encouraged to initiate community activities and events which promote community and agency service awareness, as well as youth leadership and involvement.

It is important to invest in the young people of Ravensthorpe as the limited opportunities will lead to boredom which has the potential to lead to an increase in antisocial behaviour. The current crime statistics shows that there is currently a low crime rate within the Shire of Ravensthorpe however if not sufficiently planned for the forecasted rise in population of young people could see a rise in crime.

## Vision

The vision statement for the Shire of Ravensthorpe is “Growing our Community”. This Youth Activity Plan is a commitment to that vision. By investing in infrastructure and programs for young people the Shire is responding to the needs and aspirations expressed by the community. The actions to come out of this plan will encourage participation in community life and enhance the health and wellbeing of young people making it an attractive place for families to work and raise their children.

Investing in infrastructure that helps meet the needs of young people will also benefit the wider community and strengthen the tourism industry within the region by providing fun and exciting activities for families and young people.

## Objectives/Scope

- Providing infrastructure and activities for young people so they enjoy living in the Shire of Ravensthorpe.
- Prevent antisocial behaviour that may occur from the rise in population and boredom.
- Connecting young people in the Shire.
- Establish a Youth Advisory Council to ensure that young people have a voice in the community.

## Methodology

### Student Consultations

In order to determine what activities young people would like in both Ravensthorpe and Hopetoun, students from RDHS and HPS participated in a series of focus groups. There were four separate focus groups and the method was adjusted to fit the size and age of the groups. In total 66 young people participated in the consultation.

The first group were the Student Councillors of RDHS. There was nine representatives in this group with students from year's five to twelve, who resided in both Hopetoun and Ravensthorpe. The student councillors listed all the activities for young people that are currently available, the challenges they face and the barriers in accessing activities as well



as provided ideas about the kinds of activities they would like to see in the future. The students were each given three stickers and were asked to place them next to their top three priorities.

The second focus group was the high school students of Ravensthorpe. Nineteen students participated. Eight students were from Ravensthorpe and eleven from Hopetoun. Because of the large group size and time constraints, the group was broken up into four smaller groups and based on the challenges they faced accessing facilities and activities they brainstormed activities they would like to see in the next five years. The students were each given three stickers which they then placed next to their highest priorities. The students were able to choose ideas from other groups.



While the plan focuses on young people aged between twelve and eighteen, the decision was made to consult with the younger students, as these students will be most impacted by the recommendations made from this report. Sixteen students from age six to twelve participated, all of them live in Ravensthorpe or on rural properties out of town. It is recognised that the needs and interests of young people change as they get older however it is still important to capture the ideas of this age group. The students were asked to list all the activities they currently enjoy. They were also asked to think about activities they like to do when they visit other places on school holidays or activities they liked to do if they had lived in another place. This was to get them thinking about the activities they would like to see in their own town. They were then asked what activities for young people they would like to see in the future. This group were not asked to priorities as the reading level varied due to age.

The fourth group were students from Hopetoun Primary School from years five to seven. There were a total of twenty two students involved in the consultation. As in the previous focus groups, students were asked to list current activities and any barriers that may restrict access to activities. They were also asked to think about activities they like to do in other places to help identify examples of the kinds of activities that they would like to see in Hopetoun. They were then asked what activities they would like to see in the future and also more specifically what activities they would like to see in a Youth Centre. They were given the opportunity to priorities using the three stickers like the previous groups.

## Community Consultations

The broader community were invited to attend one of two consultations in Ravensthorpe and Hopetoun. Flyers were sent out through networks and it was advertised through schools and community groups. Both consultations were poorly attended, with no one attending the Ravensthorpe consultation and four people attending the Hopetoun consultation.

Due to the low numbers, a survey was developed to help capture the thoughts/comments of parents, community groups and other young people who are no longer of school age. Please see appendix one to view the survey questions.

The survey was distributed through schools and through community networks. In order to make it more convenient for participants, there were a number of drop-off points including the Shire, all schools and the Hopetoun Community Resource Centre. Seven surveys were completed.



## Findings

### Challenges/Barriers

A popular assertion is that there are currently very few activities for young people apart from structured recreation, such as team sports. Current activities in Hopetoun include 'hanging out' at the skate park, however this skate park has been described as dangerous and small. Despite this, the skate park still gets used as there are limited places for young people to meet. Other activities include jetty jumping and riding scooters around town. Both communities identified a lack of an integrated footpath network as an issue. Young people are forced to ride on the street and as a consequence have had their scooters confiscated by the local police.

It was identified that there is a lack of activities for young people to do after school and during the school holidays. The limited options on offer for young people means that many find themselves bored. Boredom can lead to anti social behaviour as young people look for ways to occupy themselves. It is important to have a diverse mix of both structured and unstructured activities on offer for young people to participate in.

There have been opportunities in the past for young people to take part in dance and drama classes using the Hopetoun town hall as a venue, however, the instructors have moved on and there has been no one to replace them. The lack of skilled instructors to run art and recreation classes were identified as an issue at the Hopetoun community consultation.

The Arts Council and Hopetoun Progress Association are very proactive in the community and organise a range of entertaining and educational activities and events for young people and families to enjoy. One of the criticisms is that the educational classes, such as photography, are not on an ongoing basis and often targeted at beginners. Young people have expressed that they want to be able to develop their skills further.

In Ravensthorpe, there is very little infrastructure or activities for young people, other than structured sports at the Recreation Centre. The parks are run down and are not appealing to young people. When asked what activities they currently do, many of the young people provided examples of activities they did at home or on their family farm. They also said that they liked to visit the pool, however, this is made difficult because by law they are required to be accompanied by a parent or guardian. This is difficult for young people whose parents work, especially during the school holidays.

Limited transport and access has been identified as a major issue for young people. One of the major challenges is that young people live out of town on the family farm and are unable to make their own way into town. Furthermore young people from Hopetoun attend Ravensthorpe District High School and the students build friendships over the school term but find it difficult to 'hang out' over the school holidays because they live approximately 50 kilometres apart. There is a community bus, but due to the cost, groups are discouraged to use it. Young people rely on their parents to transport them as there is no opportunity for them to visit their friends or use the facilities the other town may have to offer.

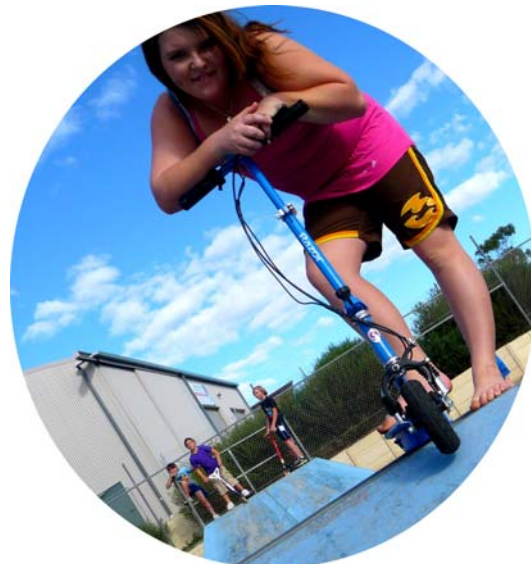
Although not identified by the young people themselves, it is apparent that there are few community groups and no paid officer to develop and coordinate activities for young people within the Shire of Ravensthorpe. It is essential to have staff and volunteers dedicated to plan, organise, coordinate and operate youth activities. It is important to have a Youth Officer to help build partnerships within the community and build the capacity of community groups. Relying on volunteers alone can be problematic as it can lead to mismanagement, burnout, low retention rates and difficulties in recruiting new members.

## Opportunities

Participants identified a need for a dedicated place for young people to meet. The most popular suggestions included skate parks and a youth centres in both Ravensthorpe and Hopetoun. Young people also wanted to see more water activities.

This could be achieved by improving access to the existing pool at Ravensthorpe and installing new equipment such as inflatable slides and obstacles.

Improving footpath networks and parks were also listed as a priority. By creating parks that are more appealing to young people, aged between twelve and eighteen, it provides another



space for young people to meet. Installing exercise equipment and water activities are just a couple of examples provided by participants. There is also a flow on benefit to the wider community as parks can be used by the general community and tourists.

Participants at the Hopetoun Community Consultation and on the survey identified a need for a Youth Advisory Council. It would be preferable to have one Youth Advisory Council for the Shire of Ravensthorpe with representative from both Ravensthorpe and Hopetoun that was coordinated by a Youth Officer. Although initial consultation has taken place to develop an overall plan for youth activities, it is essential that young people are consulted on an ongoing basis as the plan is implemented.

The following tables outline the future opportunities identified by young people and the community. The tables have been broken down into key themes including parks and skate parks, water activities, other infrastructure, possible school holiday activities, art activities and recreational activities.

# Recommendations

## Infrastructure

Provide a range of appealing, safe, accessible and affordable facilities that aim to attract and cater for young people.

### Rational:

- There is an identified need by young people for a dedicated place for young people to meet. A Youth Centre will provide young people with a place to meet friends and engage in purposeful and fun activities in a safe and controlled environment.
- Skate park, parks and water activities will provide young people with a choice of places to 'hang out'/meet and will allow them to take part in unstructured recreational activities.
- Currently young people are required to have an adult accompany them to the public swimming pool as some parents work during the after school hours and on school holidays this restricts access for young people.

## Activities

Provide young people with a range of activities that cater for the diverse needs of young people.

### *Rational:*

- Young people have diverse interests it is important to cater to the range of needs of young people. Keep young people interested and active in community life.
- Providing structured activities will reduce boredom over the school holiday periods and weekends.

## Transport

Improve transport and access between Ravensthorpe and Hopetoun (and rural properties).

## Ongoing consultation

Ensure that young people have a voice in the community and are consulted on all decisions that will impact them.

### *Rational:*

- Young people should be given the opportunity to contribute their ideas

- Young people are more likely to respect environments if they are involved in the planning.
- Involvement in planning will contribute to the positive development of young people.

## Partnerships

Establish partnerships at a local level with schools, community groups, businesses and young people working together on youth initiatives.
