6. ADMINISTRATIVE ITEMS

- ID – requested confirmation on whether owning Galaxy shares posed as a conflict of interest. HT confirmed that this is not a conflict of interest.

7. GALAXY PROGRESS REPORT

- **Mt Cattlin Processing Plant upgrade:**

- The project is progressing well, the intended completion remains December 2018.
- The Mt Cattlin Connect will provide the community with an update on the project.

- **Dust and noise monitoring results provided in a report:**

- Monitoring data reviewed by the CCG. Feedback was provided to Galaxy. The previously provided information has been either too complex or did not provide enough detail to enable general community members to understand. The next Mt Cattlin Connect will include information on monitoring that can be understood by the general community.

Noise monitoring - All noise emissions were compliant with the regulation 'assigned levels'.

- The operations at the Galaxy mine site were observed to be operating in accordance with the site Noise Management Plan and based on the monitoring and observations made on the 10th and 11th August 2018, compliant with the requirements of the Environmental Protection (Noise) Regulations.

Dust monitoring

- **Dust Deposition** - no excursions of the NSW impact assessment criteria for deposited dust of 4 g/m²/month.
- **PM₁₀ HVAS**
 - **all data has returned a 24-hour PM₁₀ concentration of 'below detection'** except for a sample taken on the 10 July 2018. This sample returned a 24-hour PM₁₀ concentration of 10 µg/m³.
 - This single detectable concentration is **well within the National Environmental Protection Measurement (NEPM) criteria of 50 µg/m³** for PM₁₀ for an averaging period of one day.
 - **Silica and Mica results** returned for 7 August was **below the detection limit of 0.005 mgm³**

8. COMMUNITY ENGAGEMENT ACTIVITIES

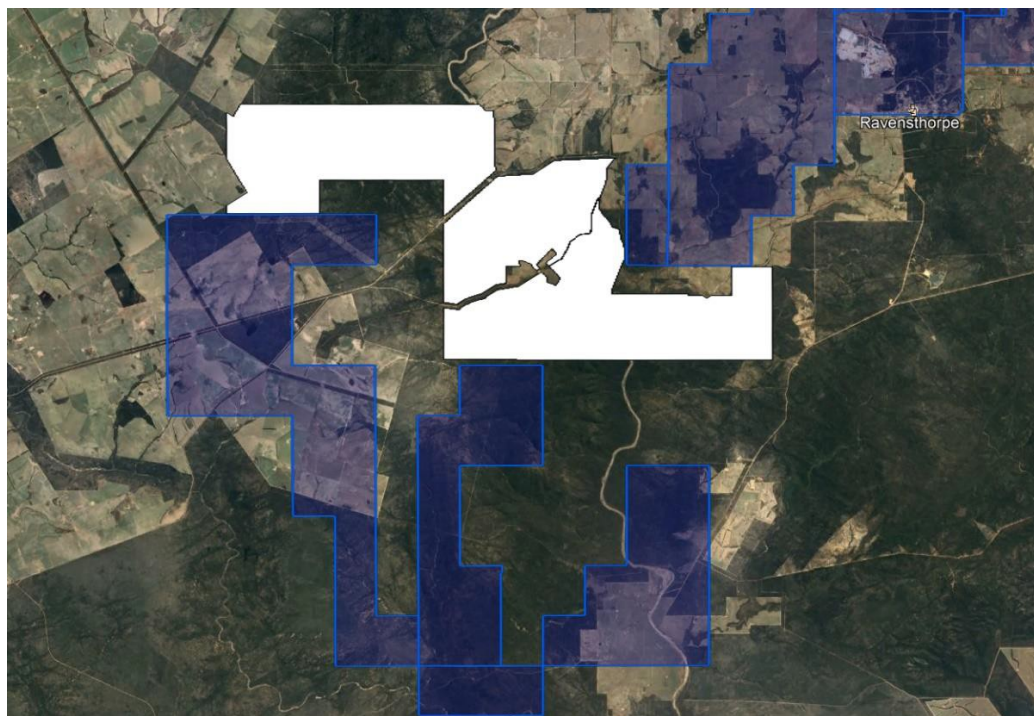
- Pitch your project was held with a good attendance from members in the local community. Projects are being reviewed.

- **SL**- Rosemary Jasper wants to know what is happening with the Salmon Gum reserve, is it a tenement owned by Galaxy. (Cocanarup Timber Reserve).
 - o **PM** – Exploration are working on tenements in that area but I am not sure if Cocanarup is within the tenements owned by Galaxy.



- o The above map shows Galaxy's tenements (blue shaded area) relating to the Cocanarup Timber Reserve (white shaded area). Galaxy does not own any tenements within the reserve area.

- **BM-** Is Galaxy responsible for damage to houses from blasting, as new cracks have recently appeared in our house's walls.
 - o **IF** - It is possible the cracking is due to the seasons we have had this year and the expansion and contraction of the well-known Ravensthorpe clays, and possible bad foundation of houses, this is the case for my house and cracking has been occurring for a while.
 - o **GF** - The foundation for my houses pad took the soils into consideration and the clay was removed, my house is showing signs of cracking in the walls.
